# Minimum Numbers

We seldom cancel a tour but regretfully reserve the right to do so where there are insufficient bookings eight weeks before departure. In those circumstances full payment including your deposit will be refunded; unfortunately we cannot accept liability for any other expenses you have incurred such as the purchase of non-refundable travel tickets.

## Cancellation

There is a deposit - payable on booking - of £100 per person. It is non-refundable if you have to cancel for any reason. The full balance becomes due and must be paid by August 31st 2016. If for any reason, the balance is not received by us by the due date, we reserve the right to treat your booking as cancelled as at that date.

All cancellations must be made in writing by the person who signed the booking form, and sent to 'Stockens Ltd', Hurlingham Studios, Ranelagh Gardens, London, SW6 3PA

If the cancellation is within 72 days of departure the following rates will be applied to the total holiday cost calculated from the date on which we receive written notice of cancellation and taking into account the non-refundable deposit:

within 7 days of departure: 100%within 8-28 days of departure: 90%within 29-72 days of departure: 60%

Percentages are of total holiday cost. If you are obliged to cancel, you may, with reasonable notice, transfer your booking to a third party who satisfies all the conditions required by a person taking that holiday, but you will be obliged to pay for any additional costs resulting from the transfer.
